Agenda Items:

1. Impersonator Night Fundraiser-

- a. Tickets- 71 tickets were sold and they were handed out at the 2/5/19 practice.
- b. Set up needed- making sure tables and chairs are set up. Will have reserved seating for everyone.
- c. When Board Members need to arrive- 6:30 pm, doors open at 7:00 pm. Show itself starts at 8:00 pm.
- d. Other details-
 - i. Impersonator- has been confirmed and will do his own set up. He is doing his own lighting.
 - ii. Cash bar and grill is open for food- confirmed there will be extra staff on hand to accommodate this. Per Dave- Wonderland will take care of the room set up based on number of attendees, he will try to have appropriate staff to handle orders (drinks and food) and will have food be delivered to people from the grille if possible. We are not able to have the room closed for a private party but Dave agreed to try to keep our area blocked as much as possible.

- b.
